Please choose one option for tuition payments:

- I opt to have my monthly tuition withdrawn on a 10-month payment plan. Payments will begin August 1st, 2023 and end May 1st, 2024.
- I opt to have my monthly tuition withdrawn on a 12-month payment plan. Payments will begin June 1st, 2023 and end May 1st, 2024.

FUNDRAISING

*EACH FAMILY WILL BE REQUIRED TO RAISE AN ADDITIONAL \$1000 per student, for the first two students, through fundraising activities. **Please choose one option for Fundraising:**

- I opt to participate in the school sponsored fundraisers throughout the year to meet the \$1000/student requirement (for the first two students). I understand that if I do not raise the \$1000/student that I will need to pay the balance of the money not raised in monthly payments March 1st to May 1st.
- I opt to have an additional \$100/student (for the first two students) withdrawn on a 10-month payment plan to cover my fundraising. Payments will begin August 1st, 2023 and end May 1st, 2024.

MATERIAL FEES

MATERIAL FEES ARE \$400/STUDENT. You may choose to have a 1 time payment withdrawn through FACTS or 4 monthly payments withdrawn through FACTS.

Please choose one option for Material Fees:

- I opt to have my Material Fee(s) withdrawn in a one time payment. My full material fee will be withdrawn on June 1, 2023.
- I opt to have my Material Fee(s) withdrawn in 4 equal monthly payments. Each payment will be withdrawn on June 1, July 1, August 1, and September 1, 2023.

WITHDRAWAL

WITHDRAWAL:

One week notice must be given in order to withdraw a student, and an exit interview must be scheduled with the administrator. Students withdrawing after August 1st will be assessed a withdrawal fee of 10% of the annual contract. Any eligible refund is first subject to deduction of outstanding balances. Report cards, transcripts, and diplomas are held until ALL financial obligations are paid in full.
